CERTIFICATE 3 GUARANTEE INFORMATION

First Door is approved to provide Government subsidised Certificate 3 Guarantee training in CHC30121 Certificate III of Early Childhood Education and Care.

The Certificate 3 Guarantee is a Queensland Government funding program which supports people to complete their first Certificate 3 qualification.

To be eligible for the Certificate 3 Guarantee program, individuals must provide evidence they:

- Are aged 15 years or over, and no longer at school
- Are not enrolled in another qualification, excluding foundation skills training
- Permanently reside in Queensland
- Are an Australian citizen, Australian permanent resident, temporary resident with the necessary visa and work permits on the pathway to permanent residency, or a New Zealand citizen
- Do NOT hold or are already enrolled in a certificate III level or higher qualification (not including qualifications completed at school and foundation skills training)

Studying with First Door

Students enrolled with First Door access their course resources for each unit online through our student eLearning portal.

The assessment workbook for each unit is based on practical work-based activities and assessment tasks which allow students to practice and understand theory.

First Door also connects each student with an industry experienced and qualified trainer as the student's **personal mentor**. The mentor is available for **study support** and for up to a **one hour workplace mentoring meeting** for relevant units or a phone/online meeting, depending on location.

Student contribution fee

While this course is Government subsidised, the student is required to contribute towards the cost of the course under the Certificate 3 Guarantee Program Policy.

- These fees may be paid on the student's behalf by an employer or a third party but cannot be paid by First Door.
- First Door charges \$25 per unit as the student contribution fee and this fee is required to be paid before commencing each unit.

Eligibility for concessional status

At enrolment, evidence is required to establish the student's eligibility for concessional status. Students with concessional status are charged at 40% for their student contribution fees, being \$10 per unit.

Concessional status students must provide evidence for one of the following:

- evidence the student is the partner or dependant of a person who holds a Health Care and / or Concession Card and is named on that card
- evidence the student is an Aboriginal or Torres
 Strait Islander by self-declaration on the signed enrolment form
- evidence the student has a disability Pensioner Concession Card or other documentation verifying the holder has a disability

Important information

Students undertaking a qualification in Early Childhood Education & Care are required to complete **practical workplace experience** as part of your assessment.

You can only access the Certificate 3 Guarantee subsidy once, to take full advantage of this opportunity, it is important you choose the right course for you.
